

## **OSP GOLD MEDAL**

### **Approved revised Criteria for Ramzan Ali Syed Gold Medal**

1. The nominee should be a regular active member of Ophthalmological Society of Pakistan for at least 15 uninterrupted years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology.

**20 Marks**

2. He should have been a regular attendant of at least 14 national and 10 International Ophthalmological conferences and should have contributed to its' scientific sessions by presenting acceptable scientific/clinical papers as principal author. (Ten for attendance and ten for scientific contributions)

**20 Marks**

3. He should be an outstanding teacher in ophthalmology for 15 years with deep interest in teaching, training, evaluation, service delivery and research. He should have authored at least 14 original Scientific paper published in indexed national or International ophthalmic medical journals (seven as principal author and seven as co-author) or should have authored a book on Ophthalmology or contributed to chapters in three books on Ophthalmology.

4. He should be a man of high intellectual caliber with meritorious personal academic and professional record. He should have distinguished himself by making outstanding contributions to the cause of Ophthalmology and eye care in Pakistan.

5. He should have a clear record of good moral standing and high professional ethical conduct. He should not have any ill reputation for malpractices and should neither have been convicted nor ever found guilty of an immoral, criminal or professional misconduct by any court or any officially appointed investigating body.

## OSP GOLD MEDAL

### Approved revised Criteria for Noval Christy Gold Medal

1. The nominee should be a member of Ophthalmological Society of Pakistan (any category). He should also be a member / fellow of at least three more national or international organizations related to ophthalmology and eye care.

2. He should have been a regular attendant of at least 10 national Ophthalmological Conference and should have contributed to its' scientific sessions by presenting acceptable scientific/clinical papers as senior author. (Five for attendance and five for scientific contributions).

**20 Marks**

3. He should be an outstanding teacher in ophthalmology and / or eye care, for at least 10 years with deep interest in teaching, training, evaluation, service delivery and research. He should have authored at least 10 original Scientific paper published in indexed national or International ophthalmic medical journals (five as principal author and five as co-author) or should have authored a book on Ophthalmology and / or eye care contributed chapters to two books on Ophthalmology and eye care.

**20 Marks**

4. He should be a man of high intellectual caliber with meritorious academic and professional record and a history of dedicated and commendable social service to his credit. Moreover, he should have distinguished himself by making outstanding contributions to the cause of Ophthalmology and eye care in Pakistan.

5. He should have a clear record of good moral standing and high professional ethical conduct. He should not have any ill reputation for malpractices and should neither have been convicted nor ever found guilty of an immoral, criminal or professional misconduct by any court or any officially appointed investigating body.

## **OSP Lateef Chaudhry Gold Medal for Significant Contributions to Vitreo-Retinal Ophthalmology in Pakistan**

1. The Nominee should be a regular member of OSP for at least 15 years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology. 20 Marks
2. He should have created an excellent enabling environment with strong national, regional and global linkages for Residents / Fellows to enhance their skills and understanding in the management of V.R diseases. 20 Marks
3. He should have supervised / tutored / evaluated in exit exams, at least 15 Residents / Fellows with special focus on V.R diseases. 20 Marks
4. He should have presented at least 20 papers related to V.R Diseases in various national and international conferences. 20 Mark
5. He should have published at least 10 papers in national or international indexed ophthalmic journals, five as principal author and five as co-author or written a book or chapters in two books on subjects related to Vitreo-Retinal diseases. 20 Marks

**OSP Prof. Muhammad Daud Khan Gold Medal for making Significant Contributions to Ophthalmic research and development in Pakistan**

1. The Nominee should be a regular member of OSP for at least 15 years..  
20 Marks
2. He should have created an excellent enabling environment at national level with strong regional and global linkages for Resident / Fellows to learn the art and science of research in comprehensive / sub specialty based Ophthalmology including community ophthalmology and eye care delivery. 20 Marks
3. He should have supervised / tutored / evaluated in exit exams, at least 25 Residents / Fellows/ Masters and Doctoral students in comprehensive / sub-specialty-based Ophthalmology including community Ophthalmology. 20 Marks
4. He should have presented at least 30 papers on the subject related to Ophthalmology including eye care delivery and ophthalmic teaching, training, evaluation and research, in various national and international conferences. 20 Marks
5. He should have published at least 30 papers in national or international indexed ophthalmic journals, one fourth as principal author and the remaining as co-author or written a book or chapters in two books on subject related to research in comprehensive ophthalmology including all subspecialties and Ophthalmic teaching, training, evaluation and research. He should also be on the editorial board of at least three national or international medical journals. 20 Marks
6. The nominee will be required to submit the necessary credentials for such qualification (Ph.D. 30 marks, Masters 20 marks, and Diploma 10 marks).

## **OSP Ghulam Qadir Kazi Gold Medal for Significant Contributions to Paediatric Ophthalmology in Pakistan**

1. The Nominee should be a regular member of OSP for at least 15 years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology. 20 Marks
2. He should have created an excellent enabling environment for Residents / Fellows with strong national, regional and global linkages to enhance their skills and understanding in the management of childhood eye diseases. 20 Marks
3. He should have supervised / tutored / evaluated in exit exams, at least 15 Residents / Fellows with a special focus on Paediatric eye diseases. 20 Marks
4. He should have presented at least 20 papers related to Paediatric ophthalmology in various national and international conferences. 20 Mark
5. He should have published at least 10 papers in national or international indexed ophthalmic journals, five as principal author and five as co-author or written a book or chapters in two books on subjects related to paediatric Ophthalmology 20 Marks

## **OSP Raja Mumtaz Gold Medal for Significant Contributions to Ophthalmic Education in Pakistan**

1. The Nominee should be a regular member of OSP for at least 15 years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology. 20 Marks
2. He should have created an excellent enabling environment with strong national, regional and global linkages for Residents / Fellows to learn the art and science of comprehensive / sub-Specialty bases Ophthalmology 20 Marks
3. He should have supervised / tutored / evaluated in exit exams, at least 40 Residents / Fellows in comprehensive / Sub-specialty based Ophthalmology 20 Marks
4. He should have presented at least 20 papers related to ophthalmology or ophthalmic teaching, training and evaluation in various national and international conferences. 20 Mark
5. He should have published at least 10 papers in national or international indexed ophthalmic journals, five as principal author and five as co-author or written a book or chapters in two books on subjects related to Ophthalmology or ophthalmic teaching training and evaluation 20 Marks
6. The nominee will be required to submit the necessary credentials for such qualification (Ph.D. 30 marks, Masters 20 marks, and Diploma 10 marks

**OSP Mukhtar Ahmad Gold Medal for making Significant Contributions to  
promotion of Ethics and Professionalism in the practice of art and Science of  
Ophthalmology in Pakistan**

1. The Nominee should be a regular member of OSP for at least 15 years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology. 20 Marks
  
2. He should be a well known Ophthalmologist with country wide reputation for his knowledge, skills, ethics and professional values. 20 Marks
  
3. He should be a well known teacher in Ophthalmology with a country wide reputation for his innovative style in transferring knowledge, skills with very strong emphasis on moral, professional and ethical values. 20 Marks
  
4. He should be a renowned research scholar with reputation for his adherence to professional and ethical values. 20 Mark
  
5. He should be a strong national, regional and global advocate for including moral, professional and ethical values to the medical curriculum at under graduate and post graduate levels in all disciplines of modern medicine and surgery. He should also be strong advocate for cultivating and adherence to such values in clinical and surgical practice as well as research matters. 20 Marks

## **The New modified Criteria for Award of Prof. Khwaja Shariful Hassan Gold Medal**

The medal will be granted to relatively younger Ophthalmologist, who has distinguished themselves by:

1. An emerging member of teaching faculty (Senior Registrar and above, age 50 and below). 20 marks
2. Principal author of at least 10 original scientific publications, 50 % of which should be in Pakistan Journal of Ophthalmology. (Preference to be given to publications in Indexed journals). 20 marks
3. Person with high ethical standards and professionalism 20 marks
4. Person with special interest in teaching, training and evaluation. 20 marks
5. Person who has promoted innovative public health approaches to the control of Ophthalmic Communicating and Non-Communicating disorders. 20 marks



## **Criteria for Award of Prof. Dil Muhammad Mirza Gold Medal**

1. The medal will be granted to a member/associate member of Ophthalmological Society of Pakistan for 10 years.

20 marks

2. He should have manifested deep interest in promoting ophthalmic sciences in cognitive, psycho-motor and affective domain and possess an innovative mind and be blessed with extraordinary manual dexterity.

20 marks

3. He should have an evidence/record of inventing new ophthalmic diagnostic and therapeutic instruments and procedures.

20 marks

4. He should have a record of making available high quality ophthalmic instruments to members of OSP at an affordable cost and have record of promoting Pakistani manufacturing industry abroad.

20 marks

5. He should have an evidence of publishing paper on his inventions in quality ophthalmic Journals at home and abroad.

20 marks

1. The Nominee should be a regular member of OSP for at least 15 years. He should also be a member / fellow of at least three more national or international organizations related to Ophthalmology.

4. He should have presented at least 20 papers related to Orbit and Oculoplastic Sub-speciality in various national and international conferences.

3. He should have supervised / tutored / evaluated in exit exams, at least 15 Residents / Fellows with special focus on Cataract and Refractive Surgery.

4. He should have presented at least 20 papers related to Cataract and Refractive Surgery in various national and international conferences.  
20 Mark
  
5. He should have published at least 10 papers in national or international indexed ophthalmic journals, five as principal author and five as co-author or written a book or chapters in two books on subjects related to Cataract and Refractive Surgery.

## **Criteria for the Award of OSP Prof. Nadeem Hafeez Butt Gold Medal**

**(Launched in 2018)**

The Medal will be granted to the Ophthalmologist of any age group who has distinguished himself / herself by the **Leadership role from the platform of OSP**

### **Criteria:**

1. The nominee should be a regular member of OSP at least for 10 years (20 marks)
2. The nominee should have gone through various certified courses in Leadership development and subsequently displayed strong leadership role from the platform of OSP (20 marks)
3. The nominee should have served in official capacity at various designations of OSP for more than 10 years. (40 marks)
  - a. As distinguished teacher (10 marks)
  - b. As a research worker (10 marks)
  - c. As a strong advocate for prevention of blindness (10 marks)
  - d. As a leader (10 marks)
4. The nominee has participated in at least 10 national and 5 international conferences representing OSP and Pakistan (20 marks)
